# Jefferson County at a Glance



**STRATEGIC LOCATION**: Ideally positioned just 25 minutes east of Knoxville along I-40 and I-81, Jefferson County is within a day's drive of 70% of the U.S. population.



ROBUST INFRASTRUCTURE: With direct access to I-40 and I-81, rail service, a general aviation airport in Hamblen County, and McGhee Tyson Airport 45 minutes away.



**RELIABLE ENERGY**: TVA is the nation's most dependable power source and one of the largest electric power systems in the country, providing safe, reliable, affordable, and clean energy.



SKILLED WORKFORCE: A dedicated workforce pipeline supported by Carson-Newman University, Walters State Community College (Hamblen County), and Tennessee College of Applied Technology (Morristown).



**OUTDOOR PARADISE**: Surrounded by natural beauty, Jefferson County boasts access to Cherokee and Douglas Lakes, close proximity to the Great Smoky Mountains, and endless opportunities for boating, hiking, fishing, and camping.





# 2024 POPULATION 25+ BY EDUCATIONAL ATTAINMENT









#### **CIVILIAN POPULATION BY LABOR FORCE (16+)**


